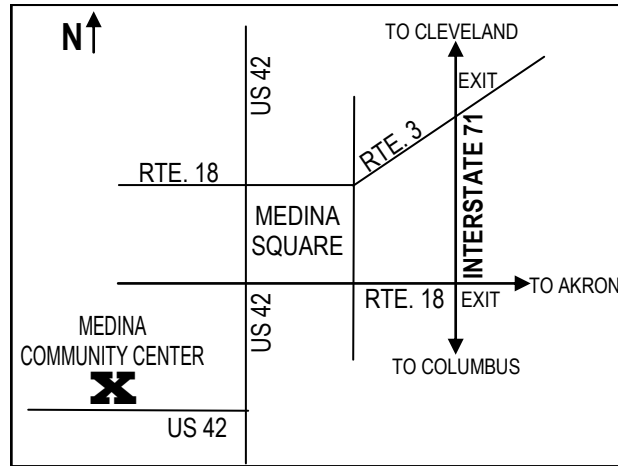

SHOW DATES & TIMES:

Friday, November 26 from 10 a.m. to 5 p.m.
Saturday, November 27 from 10 a.m. to 5 p.m.
Sunday, November 28 from 11 a.m. to 4 p.m.

Medina County Community Center

BOOTH SPACE:

Single booth—10 ft. front X 10 ft. deep for \$300 if paid in full by August 15, 2010. After August 15, 2010 the fee is \$400. After October 15—the fee is \$500. Double booth: 20 ft. front X 10 ft. deep for \$600 by August 15, 2010, \$800 after August 15, 2010, \$1,000 after October 15, 2010. Full payments will only be accepted—no deposits. Corner request—any space with 2 open sides—add \$40.

SPACE ASSIGNMENTS:

Spaces will be assigned on a first come, first served basis for the vendors who have paid in full by August 1. Requests for a particular space will only be considered for vendors who are paid in full by August 1. You will receive a letter before the show date, showing your space assignment on the floor map and confirming setup details.

APPLICATION PROCESS

1.) Please send 3 pictures—color copies—of your HAND-MADE work, one picture of your display and one of your backdrop, along with the attached Application Form and your check. You will be notified of your acceptance or rejection. Your pictures will not be returned. If you sent pictures in 2009 and you have not changed or added any products, no need to send pictures.

2.) Acceptance will be given for only the items listed on the Application Form and shown in the pictures. Additional items must be submitted for approval.

APPLICATION DEADLINE

August 15 or until full

««ATTENTION JEWELRY VENDORS««

There are only 10 spaces available for jewelry vendors. If more than 50% of your booth is jewelry, these rules apply to you: The deadline for jewelry vendor applications is June 1. At that time jewelry vendor applications will be juried as a group and only 10 will be accepted.

SET UP TIMES:

Tuesday, November 23 from 1 to 8 p.m. and
Friday, November 26 from 6:30 to 9:30 a.m.

TAKE DOWN TIME:

4:01 p.m. on Sunday, November 29—under no circumstances will a crafter be permitted to dismantle before.

PUBLIC ADMISSION CHARGE:

\$5—adults; 12 years old & under—FREE; seniors (60 & over) \$4

DOOR PRIZES:

Each crafter is asked (not required) to donate an item with retail value of \$25 or more for a door prize drawing. All customers will receive one door prize ticket when they pay admission. All items will be artfully displayed and each item will be identified by crafter and their booth space. This is provided as a marketing opportunity to promote your products away from your booth.

COSTUME REQUIREMENTS:

We encourage all crafters to dress in international costume to add to the festive atmosphere of the show. All exhibitors must be dressed in a professional manner. It projects that you are a serious artist and business person. **NO JEANS, T-SHIRTS OR CASUAL ATTIRE.**

DISPLAY REQUIREMENTS

We expect participants to make booth displays as attractive and professional as possible, following the Christmas around the World theme. Every booth **MUST** have a back drop to separate it from the booth behind and to the sides. Please describe your backdrop on the application form.

CRAFTER REFERRAL PROGRAM

Refer a new crafter to the 2010 show and receive \$50 off your booth fee in 2011. It must be a new applicant who has not been in the show for at least 5 years. Both you and the new crafter must be paid in full and attend the 2010 show for you to receive the \$50 credit in 2011. The amount of referrals is unlimited but credit cannot exceed your 2011 booth space fee. Space is provided on the application for referring crafters name.
